Any vehicle on site without proper permit is subject to impound at owner's expense. Permits for approved users will be distributed and/or available for pick-up at the ***Credential Centre located at Red Lion Hotel on the River Jantzen Beach.***

***In order to reserve your permit, the following documents must be completed and submitted by Friday, August 23, 2019:***

- Completed and Signed Motorized Vehicle Registration Application (attached)
- Certificate of Insurance, as per application
- Payment of \$50.00 via credit card or check payable to Grand Prix of Portland

**Note: any application after Friday, August 23, 2019 is subject to an additional \$50.00 fee.**

**In accordance with Oregon State Law, all operators of a two-wheeled motorized vehicle at Portland International Raceway are required to wear a motorcycle helmet that is DOT compliant.**
